

MINUTES OF THE PLEASANT TOWNSHIP BOARD OF TRUSTEES
REGULAR MEETING
JUNE 17, 2010
6:00 PM

The meeting was called to order at 6:00 PM by Chairman Moellendick with all Trustees present. Minutes from the June 3 meeting were approved as submitted.

Fiscal Officer reported the following receipts since the last meeting:

Fiscal Officer reported that PNC has refunded \$825 of the \$955.05 previously assessed as service charges.

Fiscal Officer requested a motion to renew the Fire Apparatus Fund since Capital Project Funds have a maximum life of 10 years.

10-029 Mr. Kemmerer moved to renew the Fire Apparatus Fund for replacement of a medic and/or fire engine, as provided by ORC 5705.13. Funding will be from the Fire Operating Fund, for a period of 10 years, with a target accumulation of \$600,000; seconded by Mr. Gavin. Voting: Gavin - yes; Kemmerer - yes; Moellendick - yes; Motion passed.

Mr. Bob Wilson inquired about the status of getting high grass and weeds mowed at 1475 Hillbrook. A letter requiring the property owner to mow the lot was received June 16 and they have 10 days to comply. Trustees said that the lot should be mowed before the July 1 meeting.

Mr. Bowman reported one right-of-way permit issued for \$40. A request was received for a transcript of the BZA hearing and a notice of appeal was received from the Christian Youth Center. Mr. Bowman has mailed five certified letters regarding complaints; 3 tall grass, 1 junk car and 1 business at home. He will publish a notice for 3 additional properties and also publish a request for applicants for two vacancies on the Zoning Commission.

Chief Mathias said the rescue chassis is due in June 21. EMS billing started June 1 with 21 billed runs so far this month. Chief has recommended Josh Luman for appointment as a Volunteer.

10-030 Mr. Gavin moved to appoint Josh Luman as Volunteer Firefighters, effective immediately; seconded by Mr. Kemmerer. Voting: Gavin - yes; Kemmerer - yes; Moellendick - yes; Motion passed.

Eight part-time firefighters (Jeffrey Casalina, Jordan Hatem, Jeremy Kraner, Carl Locke, Scott McCullough, Bryan Mirgon, Jason Roshon, Daniel Schultz) have not completed driver training by the June 17 deadline and will be dropped from the July and following work schedules until the training is completed.

Trustees discussed the 2011 budget.

All bills submitted were approved for payment.

Mr. Gavin moved to adjourn; seconded by Ms. Moellendick. Meeting adjourned at 7:45.
